# AKA LICENSE TAG INSTRUCTIONS North Atlantic Region

## **GROUP ORDERS**

Each AKA Chapter must designate a soror to disseminate information about ordering Maryland (MD) AKA license tags. This representative should collect the applications and complete the group form with the chapter basileus' signature and payment before submitting the order. Chapter Members(s) and General Member(s) applicants follow the steps below.

# INDIVIDUAL ORDERS

### 1) Preparing your documents.

Each applicant must submit the following to Rho Xi Omega Chapter:

- MVA Application (see next page) Do NOT sign in the space for Authorized Representative
- Copy of current vehicle registration. You MUST be listed as OWNER or CO-OWNER on the registration card.
- Copy of Alpha Kappa Alpha Sorority, Inc. financial card.
- Include your email address and telephone number.
- \$30 cashiers' check/money order made payable to: Motor Vehicle Administration (MVA).
- \$20 cashiers' check/money order made payable to Rho Xi Omega Chapter.
  - For Checks/Money Orders: A notation of the Soror's name and chapter should be on the memo line of the check/money order.
  - For Zelle: Send a payment to RXO.AcctFinance@gmail.com in the amount of \$20.00. Be sure to write in the memo/note section, AKA Tags, soror name and soror chapter.

### 2) Forwarding your documents.

### **Additional Information**

- Applications will not be processed on vehicles with temporary license plates, per MVA.
- Allow 45 60 days to receive tags. If your current tags expire on the15th, do not wait until the1st of the month to submit your application. \*\*\*MVA Alert: Due to challenges with processing or delivery, MDOT MVA's license plate orders may take longer than usual to reach customers. Applications will be processed throughout the year except during the period of December15th through January 15th. MVA will send the plates directly to the applicant/Soror when they are ready.
